Season tickets 2002/2003

Since being granted permission to relocate to Milton Keynes, the Club and its partners have been working hard to arrange a new home venue for the Club to play in until the new stadium in Milton Keynes is completed. The support and enthusiasm for a temporary solution in Milton Keynes has been overwhelming but unfortunately the Club has been unable to secure a suitable alternative venue that will be ready at this time.

As a result, the Club will continue to play its home fixtures at Selhurst Park for the foreseeable future and until such a time as a suitable alternative is available. This position will be reviewed as planning progresses, and information regarding the move will be issued to supporters both directly and via the Club's website (www.wimbledon-fc.co.uk) as it becomes available.

So what happens now?

Those of you who have already applied for a season ticket or membership for the 2002/2003 season need do nothing more. Your application is now being processed and your ticket(s) will be sent to you shortly or you will be contacted to arrange their collection.

Those supporters who have not yet renewed their season tickets but wish to do so should either call the box office on 020 8771 8841 (make sure you have your credit or debit card to hand), log on to the Club's website (www.wimbledon-fc.co.uk) or complete and return either the original season ticket application form or the form that accompanies this letter. **The discounted prices that were originally available to 30th June 2002 will now be valid on all applications received on or before 9 August 2002, after which full prices will apply.**

Watching top class professional football couldn't be better value for money. The season ticket prices represent a significant saving on the price of individual match day prices which, in common with many other Clubs, have been increased because of the limited TV income the Club will receive next season.

In the Family Stand, taking advantage of the ½ price junior season ticket offer, season tickets for an adult and two under 16's purchased on or before the 9th August 2002 will cost just £13.26 per match. Buying the same tickets on a match day for the whole season will cost £30 per match – the season ticket price means you save 55%. Adult season tickets purchased on or before 9 August 2002 will be 40% cheaper than the equivalent individual match day prices in the Main Stand and represent a 44% saving on the price of individual match day tickets for the Holmesdale Road Stand. Concessions prices will save 45% and 55% respectively and the savings for juniors (under 16's) will be 55% and 71% - even more if you take advantage of the ½ price junior season ticket offer.

Buying a season ticket doesn't only give you these great price benefits. You'll also have priority when it comes to buying away and cup tickets, free admission to all home reserve games and a 10% discount in the Club shops.

All season ticket money will be placed in a special account established by the Club, which is separate from the general account. Money can only be released to the Club upon the agreement of the independent trustee of the account under one of the following conditions:


1. As payment in arrears (on monthly basis) to the Club for delivering the product (the matches).
2. As a refund of the unused value of the season ticket to those requesting such a refund in the event of the Club moving to another venue.
3. As a refund of a portion (amount to be agreed) of the value of the season ticket as a discount to those holders wishing to transfer to a new venue.

Season tickets are valid for the whole season, irrespective of where home games are played. If the Club does move to Milton Keynes during the season, which remains a possibility, these tickets will be transferred to a similar facility at the alternative venue and agreed discounts applied. Season ticket holders who do not wish to move with the Club to Milton Keynes will be granted a refund of the unused value of the season ticket should they so request.

Wimbledon Football Club has a bright and exciting future. We hope that you will continue to be a part of it and to support Stuart and the players throughout the 2002/2003 Nationwide 1st Division campaign and for many years to come.
